  - Female Entertainer Dance Performance
  - Music with DJ
  - Pole/Sensual Dance Lessons
2. **Time & Date of Performance.** KIJAE Entertainment agrees to complete the performances of above services on. \_\_\_\_\_ [date]
  - Performance will be 30 minutes to 45 minutes in length.

3. **Payment.** In consideration of KIJAE Entertainment performance of these services, the Client agrees to pay KIJAE Entertainment as follows:

  - **Cancellations made by KIJAE Entertainment - A Full Refund of the 50% deposit will be returned to the Client.**
  - **Cancellations made by the Client - there will be No Refund of the 50% deposit.**
4. **Invoices.** KIJAE Entertainment will submit a copy of this contract to the Client for all services performed.
5. **Independent Entertainment Company.** The Client intends KIJAE Entertainment to perform these services. KIJAE Entertainment shall have the right to control and determine the method and means of performing the above services; the Client shall not have the right to control or determine such method or means.
  - **NO** photographs shall be taken of the performers during their performances including and not limited to (cameras, telephone cameras, etc...)
  - **NO** recording of any kind shall be taken of the performers during their performances including and not limited to (camcorders, video recorders, etc...)
  - Photographs may be taken before the performances begin or after the performances are completed.
  - If agreed upon in advance and at the time of the signing of this contract, photographs may be taken during the performances. The Client must supply any and all recording and photography material as needed.

6. **Other Clients.** KIJAE Entertainment retains the right to perform service for other Clients.
7. **Music.** KIJAE Entertainment will supply performance sound tracks on CD or audiotape cassette for all performances. Client will provide audio equipment; CD or tape player, amplifier and speakers for the performance.
8. **Additional Performers.** The Client may hire additional performers contracted with KIJAE Entertainment, if Client deems necessary in order to carry out this agreement. The Client will be responsible for paying such performers. The Client will be responsible for additional payment.
